Chair Gertler announced that the Commission took no reportable action in closed session on item 3.

Chair Gertler adjourned the special open session following the closed meeting at 6:45 PM.

#### PUBLIC HEARING - 7:00 PM

Chair Gertler convened the public hearing at 7:00 PM at the Harbor Public Meeting Room, 365 A Lake Avenue, Santa Cruz, CA (hybrid meeting platform).

5. Public Hearing to Receive Testimony Regarding the Drawing of Port Commission District Boundaries Pursuant to Elections Code § 21601

Port Director MacLaurie stated that this is the fourth public hearing required as part of the Port District's districting process. She stated that the Commission may consider a final map at this hearing for adoption as the official Port Commission District Map. She introduced the District's contracted demographer, Douglas Johnson, President of National Demographics Corporation.

Mr. Johnson provided a comprehensive overview of the two additional draft maps (Tan 2, and Yellow 2).

The following community feedback was received at the public hearing (via Zoom):

• Support for draft maps in which all five divisions touch the harbor (Tan and Tan 2).

A discussion ensued regarding map selection. Individual Commissioners expressed support for the following draft maps:

- Chair Gertler Green & Tan 2 (respectively)
- Vice-chair Reed Yellow 2 & Green (respectively)
- Commissioner Goddard Yellow 2 & Tan 2 (respectively)
- Commissioner Smith Green
- Commissioner Geisreiter Yellow 2 & Tan 2 (respectively)

Commissioner Goddard suggested the following revision to resolution 23-05:

- Replace "adopting redistricting maps" in the first sentence with "establishing and adopting a district-based election map".
- MOTION: Motion made by Vice-chair Reed, seconded by Commissioner Geisreiter to approve resolution 23-05, with the revision outlined above; and designate Yellow 2 as the official Port Commission District Map for attachment to Resolution 23-05 as Exhibit A.
  - Motion carried. Commissioners Reed, Goddard, and Geisreiter voting YES. Commissioners Gertler and Smith voting NO.

Commissioner Smith expressed his disappointment regarding the outcome of the Commission's deliberation during last month's meeting on the public benefit discount. Commissioner Smith requested that Chair Gertler schedule a meeting with Port Director MacLaurie to determine if additional discussions can occur at the committee level to fully vet the equity of the public benefit discount and develop standards for its application. Chair Gertler agreed and stated that he will schedule a time to meet with the Port Director.

#### **REGULAR AGENDA**

- 10. Review Investment Option California CLASS Prime
  - Discussion: Rick Wood, Finance and Administration Director for the California Special Districts Association (CSDA) provided a presentation on the California CLASS Prime (CLASS) investment option and highlighted the following:
    - CLASS Prime is a newly established joint powers authority pool sponsored by CSDA and the League of California Cities (launched July 2022).
    - The program is designed specifically for special districts and is an allowable investment instrument under California Government Code Section 53601.
    - High rate of return (4.97% vs. 2.74% with LAIF).

- Interest paid monthly (rather than quarterly).
- Short term maturities.

A discussion ensued regarding the benefits associated with establishing a CLASS Prime account. There was a consensus among the Commission to direct staff to take advantage of current market conditions and establish a California CLASS Prime account. The Commission expressed support for making an initial deposit of approximately \$13 million (from LAIF to CLASS Prime).

- MOTION: Motion made by Vice-chair Reed, seconded by Commissioner Goddard to support the Port Director in efforts to establish a California CLASS Prime investment account.
  - Motion carried unanimously.
- 11. Award Contract for Pile Repair and Replacement Project 2023 RGP Phase 1 (NTE \$1,200,000)
  - Discussion: Port Director MacLaurie stated that a request for proposals (RFP) for the Pile Repair and Replacement Project 2023 (RGP Phase 1) was advertised, commencing April 10, 2023. Port Director MacLaurie stated that four bids were received, and Cushman Contracting Corporation (Cushman) was the low bidder.

Port Director MacLaurie stated that \$615,000 is currently available in the Capital Improvement Program for the Pile Replacement project, leaving a funding shortfall of \$585,000. She recommended that the Commission authorize using \$425,000 in reallocated CIP funds and \$160,000 in unrestricted cash to cover the shortfall.

Port Director MacLaurie stated that the following correspondence has been distributed to the Commission as part of tonight's meeting and entered into the public record:

- Santa Cruz Harbor Pile Repair and Replacement Project 2023 (RGP Phase 1) – Bid Advisory, from Local Union No. 34 Pile Drivers, dated May 22, 2023
- Santa Cruz Harbor Pile Repair and Replacement Project 2023 (RGP Phase 1) – Bid Advisory Response, from Santa Cruz Port District, dated May 23, 2023

Kyle Cushman, Secretary of Cushman Contracting Corporation, expressed appreciation for the opportunity to bid on this project and stated that his firm is looking forward to working with the Port District and fulfilling the bid requirements. The Commission expressed support for approving the contract with Cushman to ensure that this critical project gets completed during the upcoming work window.

- MOTION: Motion made by Commissioner Goddard, seconded by Vice-chair Reed to award a contract for the Pile Repair and Replacement Project 2023 – RGP Phase 1; authorize the Port Director to execute the contract; authorize a notto-exceed amount of \$1,200,000 for the construction budget including a contingency of approximately 5%; and approve an appropriation in the FY24 budget for the amount of the contract plus contingency.
  - Motion carried unanimously.

SUBJECT: Approval of Lease Amendment for UCSC Community Boating Program

#### <u>Recommendation:</u> Approve the Seventh Amendment to lease.

#### BACKGROUND

The UCSC boating program utilizes dock, rowing rack, jet float, and landside storage space at and near FF Dock, under an original lease dated May 1997. The most recent lease amendment (Sixth Amendment) was executed in 2017, and expires on June 30, 2026.

Under the Sixth Amendment, UCSC leases approximately 642 SF of rowing dock and 301 SF of jet float at FF-Dock. Earlier this year, UCSC submitted a request to add one additional rack storage space to the premises after a four-person rowing shell was donated to the program. The requested rack storage space is located outside of and adjacent to UCSC's dedicated rowing dock, at space RR-41 (rowing rack under bridge).

#### ANALYSIS

Under the current lease, a market value rate is assigned to each space that is rented by UCSC. A 50% public service discount is applied to certain portions of the leasehold. The additional rowing rack space that is being proposed for inclusion into the lease premises will be charged in accordance with the District's current fee schedule (\$63.14/month) and is subject to periodic adjustments. The public service discount does not apply to this space.

The Real Estate office at UCSC has reviewed and approved the Seventh Amendment to Lease as presented. All other terms of the lease remain unchanged.

#### IMPACT ON PORT DISTRICT RESOURCES

There is no impact on Port District resources associated with the approval of this lease amendment.

#### THE REGENTS OF THE UNIVERSITY OF CALIFORNIA SEVENTH AMENDMENT OF LEASE THE REGENTS AS TENANT

THIS SEVENTH AMENDMENT OF LEASE ("Amendment") is made and entered into as of July 1, 2023 ("Effective Date") by and between the SANTA CRUZ PORT DISTRICT COMMISSION, a political subdivision ("Landlord") and THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, a California corporation ("Tenant").

Landlord and Tenant hereby agree as follows:

- 1. The Lease between the parties dated May 1, 1997, as further amended on September 1, 1997; November 20, 2000; April 26, 2007; April 10, 2012, May 26, 2015, and February 28, 2017, for certain Premises located at the Santa Cruz Small Craft Harbor at 135 Fifth Avenue in Santa Cruz, California, is hereby amended as follows:
  - a. In Section 1 titled, "Rental of Premises," sub-section titled, "Premises," is deleted in its entirety and replaced with the following text to include the addition of one rowing rack space commencing on April 1, 2022:

"Premises (as further described in Exhibit A):

- One hundred linear feet (100') dock space at FF-Dock
- Two hundred fifty-three square feet (253 SF) office space
- One thousand eight square feet (1,008 SF) fenced storage area including two storage sheds (each one hundred twenty-one square fee [121 SF] in size)
- Three hundred one square feet (301 SF) jet float kayak rack space
- Six hundred forty-two square feet (642) SF rowing dock
- Four (4) boat slips
- One (1) rowing rack space for four-person shell (RR-41)"
- 2. Exhibit A, "Premises" (map), is deleted and replaced with new Exhibit A (attached).
- 3. In Section 1 titled, "Rental of Premises," sub-section titled, "Rent," is deleted in its entirety and replaced with the following:

"Base Rent for the Lease Term exclusive of the rent for the boat slips and rowing rack space shall commence at One Thousand Nineteen Dollars and 29/100 Dollars (\$1,019.29) per month or \$12,231.48 annually, monthly rent shall be increased annually on July 1st in accordance with the increase in the San Francisco-Oakland-Hayward Consumer Price Index (All Items) for the preceding calendar year. In no event shall the Base Rent be decreased. Additional Rent for the four (4) boat slips and one (1) rowing rack space shall be charged in accordance with the fee schedule currently in place and amended from time to time by Landlord."

4. Except as expressly amended above, the Lease remains in full force and effect



SUBJECT: Consideration of 6-Pak Charter Permit Application – Ocean Safaris (J. Moskito)

# <u>Recommendation:</u> Consider authorization of a north harbor charter operation (6-pak) for James Moskito of Ocean Safaris.

#### BACKGROUND

James Moskito has over 20 years of experience as a charter operator. He founded his company, Ocean Safaris, in 2000, and has since logged thousands of hours as a charter captain, dive instructor, and naturalist. Mr. Moskito recently obtained a north harbor 30' slip on J-Dock (through the waiting list) and has submitted a proposal to operate a 6-pak charter with an emphasis on wildlife viewing. Mr. Moskito's vessel is a twin-engine, 33' rigid-hull inflatable with seating for six passengers.

#### ANALYSIS

There are currently four approved charters operating from various docks in the north harbor. No charters are operating from J-Dock. North harbor parking in the area of J-Dock is plentiful and there is already a pay station located in the vicinity where customers can purchase an hourly or daily parking pass.

Mr. Moskito has completed the charter application and paid the associated fee. He currently has \$1 million in commercial liability insurance with the Port District listed as additional insured on the certificate. Mr. Moskito holds a 100-ton Master Merchant Mariner Credential with the U.S. Coast Guard.

Overall, staff feels this is a reasonable request with a negligible impact on north harbor operations.

#### IMPACT ON PORT DISTRICT RESOURCES

If approval is granted, the Port District will generate an additional \$750 in charter fees annually, and associated visitor parking revenue.

#### <u>Recommendation:</u> Consider authorization of a south harbor charter operation (6-pak) for Greg Webb of Cod Mountain Fish Company

#### BACKGROUND

Greg Webb has been involved with Santa Cruz-based fishing charters for the last 10 years, both as a deckhand and as a licensed captain. He currently has a commercial fishery slip on S-Dock and has been selling his catch directly to customers at a Sacramento-area farmers market. Mr. Webb has submitted a proposal to operate a six-pack charter, in conjunction with his commercial fishing business, Cod Mountain Fish Company.

#### ANALYSIS

There are currently three 6-pak charters operating from S-Dock (Monterey Bay Charters [T. Dolan], Chartle Charters [J. Stoops], and Santa Cruz Coastal Fishing Charters [R. Armstrong]). When considering Mr. Webb's request, if the Commission has concerns about the number of charters currently operating from a single dock, an alternative commercial slip on R-Dock can be utilized. There are currently no charters operating from R-Dock.

Mr. Webb's license will allow him to carry a maximum of six passengers; however, due to the vessel's size, he intends to carry a maximum of four. With a four passenger load, impacts to parking are expected to be minimal, as groups will likely travel to the harbor in one or two vehicles. Daily parking passes can be purchased at the pay station near the fishery landing. Most charters will finish in the late morning allowing the affected parking spaces to be used by afternoon visitors and restaurant patrons.

Mr. Webb has completed the charter application and paid the associated fee. He currently has \$1 million in commercial liability insurance with the Port District listed as additional insured on the certificate. Mr. Webb holds a 100-ton Master Merchant Mariner Credential with the U.S. Coast Guard.

#### IMPACT ON PORT DISTRICT RESOURCES

If approval is granted, the Port District will generate an additional \$750 in charter fees annually, and associated visitor parking revenue.

# <u>Recommendation:</u> Authorize the purchase of a new boiler unit for 2222 East Cliff Drive in an amount not to exceed \$31,000.

#### BACKGROUND

The boiler serving upstairs and downstairs tenants at 2222 East Cliff Drive failed during the 2022-23 winter. While diagnostic tests and repair options were explored, tenants were offered individual space heaters as an interim solution.

The boiler unit is original to the building and was installed in 2004. Due to its age, parts are difficult to obtain and identifying a cost-effective, long-range repair option is challenging. Full replacement of the unit is recommended.

#### ANALYSIS

A \$7,000 estimate was provided by AirTec Services to repair the boiler. AirTec has indicated that the repair is not guaranteed to bring the boiler back to an operable condition (i.e., full replacement may still be warranted after the repair is made).

Rather than spend \$7,000 on a potentially ineffective repair, staff recommends purchasing a new boiler unit in the amount of \$31,000 (Attachment A). The boiler unit is in stock and has a minimal lead time for installation.

#### IMPACT ON PORT DISTRICT RESOURCES

Acquisition of a new boiler unit is an unanticipated expense in the FY24 budget; however, adequate funding is available in the Capital Improvement Program. The Building Restoration Fund has a balance of \$178,861, as of May 31, 2023.

SUBJECT: Port Director's Report – June 27, 2023

#### Meeting with County Administrative Officer

On May 24, 2023, I met with CAO Carlos Palacios to discuss projects and initiatives of mutual concern between the County and Port District. The meeting was requested by CAO Palacios to gain insight into the harbor's current operation. Discussion topics included a status update for the County-owned parcel at 7<sup>th</sup> and Brommer and the potential for increasing the County's rescue grant contribution to the District's marine search and rescue program.

#### Staff Visit – Congressman Panetta

On May 30, 2023, Legislative Assistant and Correspondent for the Office of Congressman Panetta, Liz Jacobson, met with staff and toured the harbor. Ms. Jacobson is familiar with the Port District's dredging operation and has been instrumental in coordinating congressional support for the District's annual dredge reimbursement from the U.S. Army Corps of Engineers. The visit provided an opportunity for Ms. Jacobson to see other aspects of the harbor, like the commercial fishing fleet and storm-damaged infrastructure.

## California CLASS Investment

The Port District's new investment account with California CLASS Prime was established on May 31, 2023. Monthly interest for the account is estimated at \$58,000. Financial reporting for this account will be included in the agenda packet on a monthly basis (Financial Reports).

## FY23 Audit Initiation

Field work for the FY23 audit is anticipated to commence in early July. It is anticipated that the draft audit will be presented to the Commission for review at its regular public session in August, with final acceptance occurring in September.

#### 2222 East Cliff Drive

Staff continues to work with the City of Santa Cruz Building Department on issuance of a building permit for the 2222 East Cliff Drive Deck Replacement Project. Final plans and documents were submitted to the City on June 13, 2023. Staff anticipates that the permit will be available to pull in the next 2 to 3 weeks. Project commencement will be weather dependent, but will not occur prior to Labor Day weekend.

## California Coastal Commission Site Visit - Coastal Rail Trail Project (Segments 8 and 9)

On July 10, 2023, representatives from the Coastal Commission will be onsite to discuss the City's future Rail Trail Project. The meeting will include an extensive walkthrough of the site and District staff will provide valuable information regarding the potential impacts associated with the proposed installation of a west and/or east harbor trail connection, public safety, and traffic safety.

#### Monterey Bay Salmon and Trout Project Salmon Release

During the evening of May 31, 2023, the Monterey Bay Salmon and Trout Project, in partnership with the California Department of Fish and Wildlife, released an estimated 160,000 juvenile salmon in the waters of the Monterey Bay. The 4"-5" fish originated from the Mokelumne River Hatchery and were released directly off the Santa Cruz Municipal Wharf. The planting of these fish represents a substantial benefit to the Monterey Bay fishing economy and the Port District.



#### Santa Cruz Yacht Club Events

The Santa Cruz Yacht Club has had a busy start to the summer boating season with several recent events including the Moore 24 regatta (May 20-21), the Santa Cruz 27 Nationals (May 27-29), and the Little Boreas race from Santa Cruz to Moss Landing (June 10). Staff continues to work closely with SCYC representatives to ensure adequate end-tie space is available for their use during club events. Staff is also engaged in planning for the upcoming "Day on the Bay - Big Brothers Big Sisters Regatta" scheduled for August 6, 2023.

#### Sanctuary Advisory Council (SAC) Meeting

Staff virtually attended the Monterey Bay National Marine Sanctuary Advisory Council meeting which was held in Cambria on May 19, 2023. The main item on the agenda was a presentation from the Director of the West Coast National Marine Sanctuaries about the status of designating the Chumash National Marine Sanctuary. Staff commented on the impacts of rulemaking on harbor operations when designating new sanctuaries. While the Director couldn't comment on dredging rules for the proposed sanctuary, he confirmed that there have been many meetings between Sanctuary Staff and Morro Bay and Port San Luis Harbors.

#### Deputy Harbormasters Honored

Senior Deputy Harbormaster John Haynes, Deputy Harbormaster David Hill, and Deputy Harbormaster Parker Guy were honored at the California Association of Harbormasters and Port Captains annual conference in Sacramento on May 25, 2023. The three staff members received recognition for their efforts in apprehending a suspect in an attempted boat theft on April 10, 2022. The individual was also wanted for murder in Humbolt County. He was subsequently found guilty on all counts and sentenced to 25 years to life on May 24, 2023.



#### Memorial Day Paddle Out

Harbor Patrol participated in a Memorial Day paddle-out in Capitola honoring fallen service members. The event was organized by the Santa Cruz Veteran's Surf Alliance, which is a local non-profit supporting veterans.

#### City of Santa Cruz - Local Discharge Limits, Wastewater Sewer System Compliance

Boatyard staff attended a City of Santa Cruz Wastewater compliance update meeting on June 14. The meeting was part of an update process for discharge limits and source control related to the Pure Water Soquel project, which is set to become operational in 2024. Based on the information provided in the meeting, boatyard discharge limits should not be affected by the update as the substances of concern are not typically produced by boatyard activity.

#### Fisheries Report

The fisheries report consists of data from two sources: the Department of Fish and Wildlife (DFW) and the H&H Fresh Fish (resident fish buyer). The data from DFW is partially redacted in accordance with federal fisheries laws. Data is considered confidential when less than three separate vessels land species at any one port. For species landed by three or more separate vessels, the full data is made public and includes weight and value. For other data, the species landed is shown with no weight data.

#### **Dredging Operations:**

#### Twin Lakes

The dredge crew successfully moved *Twin Lakes* back to her offseason mooring on June 8, 2023. Offseason maintenance has begun and will run through November 1, 2023. Lind Marine will be onsite in July to perform the biennial inspection of the dredge (report to follow).



<u>Squirt</u>

Squirt has been hauled out at the boatyard and is undergoing yearly maintenance.



#### <u>Dauntless</u>

Crews plan to haul out *Dauntless* at the boatyard on July 5, 2023, for routine maintenance and inspections to be performed.

#### Maintenance / Projects:

#### Electrical Service Upgrade Project - 333 Lake Avenue

The Electrical Service Upgrade project at 333 Lake Avenue has been completed and signed off by City building officials. Tenants in the building have been advised that individual utility assessments will now be performed as a result of the new metering.

#### Deck Replacement Project – 2222 East Cliff Drive

Building permits for this project are pending final issuance (anticipated in the next 2-3 weeks). Staff has been in contact with the project contractor, SSB Construction, to formulate a schedule for construction. Construction will not start prior to the Labor Day weekend, and extensive outreach will be performed to tenants in the area.

#### G-Dock Lift Station Replacement

Staff is currently drafting a Request for Proposals (RFP) for the G-Dock Lift Station Replacement project. Advertising is scheduled to commence in early July. MKN Engineering has completed the design and we are ready to get this project started.


#### Pile Repair and Replacement Project

The contractor for the project anticipates project commencement to occur in late July / early August. Due to the need for additional pile sleeving, a \$17,000 change order has been executed and deducted from the project contingency. A more accurate start date will develop as we get closer to the middle of July.

#### I-Dock Restroom Rehabilitation Project

A City building permit for this project is pending final issuance (anticipated in the coming weeks). Staff is currently researching other permit needs (i.e., Coastal Commission, Waterboard, Corps). A more definitive project timeline will be developed soon, but adequate project funding is available to start work.

#### Search and Rescue, Patrol Boat Response
