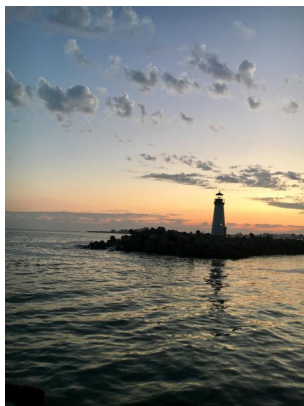

## J-DOCK SHOWER RESTORATION

As a part of the District's capital improvement program, maintenance crews have completed an extensive remodel of the west side shower at J-Dock and have now begun repairs on the easterly shower. Crews have demolished the easterly shower, replaced the subfloor and joists, and roughed in plumbing and electrical. Crews anticipate that dry wall installation will begin in early-October. We apologize for any inconvenience this repair work may cause, but are confident that the new shower facilities will be worth it!

## CALIFORNIA BOATER CARD INFORMATION

Beginning January 1, 2018, the Division of Boating and Waterways will require boat operators aged 20 years and younger to possess a California Boater Card when operating any motorized vessels on state waters. Each year after January 2018, the program will be expanded to include additional age groups. By 2025, all persons who operate a motorized vessel will be required to pass an approved boating safety examination and carry a lifetime California Boater Card.

The California Boater Card will show that its holder has successfully taken and passed a NASBLA/state-approved boater safety examination. For more information about the California Boater Card, please click [here](#).

## 2017/18 DREDGING UPDATE

North harbor dredging was anticipated to commence on October 2, 2017, but has since been delayed to October 9, 2017. Crews are currently awaiting the arrival of a repaired jet pump (currently in transit), as well as hydraulic cylinders for the snorkel. Once the equipment has arrived, crews will perform the necessary installations and begin dredging. *Twin Lakes* will efficiently facilitate dredging the area of the X-J fairway to design depths.

Crews will move *Twin Lakes* to the south harbor to begin entrance dredging in early-November. Remaining dredging of the north harbor will be accomplished using the District's smaller, 8" dredge, *Squirt*.
