

REGULAR PUBLIC MEETING TIME

JOIN US FOR A NEW, EARLIER REGULAR PUBLIC MEETING START TIME

On July 25, 2023, the Santa Cruz
Port Commission approved an
amendment to adjust the start
time of its regular public
meetings from 7 PM to 5:30 PM
on the 4th Tuesday of each
month. This change will be
effective with the regular public
meeting on August 22, 2023.
Participate virtually or in-person!

On May 23, 2023, after a robust and deliberate public process, the Santa Cruz Port Commission adopted Resolution 23-05 to change from at-large to by-district elections, and established boundaries and sequencing of future elections within the individual districts.

All current Port Commissioners will continue to represent the District at-large until such time as they may be re-elected to represent their respective districts or leave office.

In November 2024, voters will experience by-district voting for the first time. Candidates for the Santa Cruz Port Commission must reside within Districts 1, 2, and 3. Only voters within said districts will be eligible to vote for candidates vying to represent their respective district. In 2026, voters in Districts 4 and 5 will vote under the same procedures as described. To learn more about the individual districts or view a larger map, please click here.







IMPORTANT SAFETY REMINDER FOR BOATERS

Did you know that pursuant to Santa Cruz Municipal Code, the area between Abbott Lighthouse at Steamer Lane and the tip of the west jetty is a designated 5-knot speed limit zone?

With an increase in boating activity and water use during the summer months, please be mindful of this regulation when underway in this area.

Keep a sharp lookout for swimmers, paddle boarders, and kayakers, and go slow in this zone.



CHANNEL NAVIGATION

During the busy boating season, Port District staff would like to remind boaters of the rules governing vessel traffic within the harbor channel. The Inner-Harbor Vessel Traffic brochure, which provides a comprehensive listing of the Rules Governing Inner-Harbor Vessel Traffic, is summarized below:

- The speed limit within the harbor is 5 MPH.
- Sailboats may tack across the channel, even if such tacking places the vessel in violation of the "keepto-the-right" rule.
- When tacking across the harbor channel onto the side of the channel that places the sailboat in violation of the "keep-to-the-right" rule, sailboats shall yield to oncoming vessels so as not to cause an oncoming vessel to alter speed or course.
- All vessels crossing the main harbor channel, or leaving a fairway, shall yield to any vessel transiting the main channel.
- Paddlers must keep to the right at all times, and no more than two abreast. A paddler may choose to cross over to the opposing side of the channel to exit or enter the harbor entrance.
- Human-powered watercraft are not allowed in the launch ramp area at any time, or operate in fairways and other prohibited areas (see maps).
- Paddlers are advised to stay well clear of aerators, which can present a danger whether or not they are in operation.
- Please observe the signs! Swimming and prone paddling in the harbor is prohibited.
- While on the water, please observe these "rules of the road" and have a safe and enjoyable boating season.

CERTIFIED CLEAN MARINA

The Santa Cruz Port District has once again earned a Clean Marina designation! Since 2007, the District has routinely completed the rigorous recertification process, which takes place every five years to maintain its Clean Marina designation. The district earned the certification with a high score of 95%.

The Clean Marina Initiative is a voluntary, incentive-based program that encourages marina operators and recreational boaters to protect coastal water quality by engaging in environmentally sound operating and maintenance procedures. While Clean Marina Programs vary from state to state, all programs offer information, guidance, and technical assistance to marina operators, local governments, and recreational boaters on Best Management Practices (BMPs) that can be used to prevent or reduce pollution. Marinas that participate in the Clean Marina Program are recognized for their environmental stewardship.




SEPTEMBER IS COASTAL CLEAN UP MONTH

However you choose to participate, thank you for keeping our beaches and waterways clean and healthy!






U.S. COAST GUARD AUXILIARY BOATING SAFETY CLASSES
