CLEAN & GREEN BOATING TIP

If you change your boat engine oil, be sure to use a closed system (such as a portable oil-change pump) available at marine supplies stores and always have an oil absorbent pad handy.

Drain the used oil into a container that can be closed to prevent spills. Properly dispose of saturated absorbents and remember to recycle your used oil and oil filters.

NORTH HARBOR PARKING PAY STATION

The Santa Cruz Port District has recently installed a new parking pay station in the north harbor. The new, easy-to-use pay station is located at the bottom of the Brommer Street entrance near J Dock and provides slip renters and visitors with the option to purchase hourly or daily parking passes. Passes are only valid in visitor parking spaces - they are not valid in spaces marked "Slip Renter Only."

For convenience, all major credit cards, cash, and coin are accepted for payment. This pay station was installed in response to demands for more options for purchasing long-term parking passes without needing to visit the office, locate a parking attendant, or risk citation.

PARKING MANAGEMENT PLAN - STAKEHOLDER MEETING

The stakeholder meeting held on August 11, 2015, with the Port District's parking consultant was well-attended. Participants provided valuable input and posed questions that will help with the development of new parking management strategies.

A second stakeholder meeting is planned to review the consultant's analysis of parking demands and opportunities, and solicit feedback from all user groups. That meeting is anticipated to occur in mid to late-September. Meeting notices will be posted and emailed in advance.
