## 2014-15 DREDGE SEASON UPDATE

The Santa Cruz Port District is currently soliciting proposals from firms interested in engineering, design, construction, delivery, and testing of a 16 inch steel-hulled hydraulic dredge for dredging the Santa Cruz Harbor. It is the intent of the Port District to replace its 1986 16 inch dredge *Seabright* currently used for dredging operations in Santa Cruz Harbor with a new vessel with specifications and equipment, likeness, and features similar to those of the vessel currently in use.

Bids for this project are due by February 13, 2015, with anticipated delivery of a new dredge in June 2016.
