PARKING MANAGEMENT PLAN - STAKEHOLDER MEETING

The Port District and its parking consultant, Watry Design, Inc., hosted a stakeholder meeting on August 11, 2015, to discuss parking demands and ideas for improving parking availability throughout the harbor. The ideas and feedback received at this meeting were valuable and have been reviewed and incorporated into the overall parking analysis.

IMPLEMENTATION OF ELECTRONIC KEY SYSTEM FOR SHOWER FACILITIES

Implementation of the Port District's electronic key system for shower facilities has begun. Distribution of keys for slip licensees will occur beginning on September 23, 2015. One shower key will be issued per slip licensee for a non-refundable fee of \$25. Dry storage renters, partners, and co-licensees are not eligible to purchase shower keys.

Commencing September 23, 2015, metal shower keys will no longer provide access to the shower facilities.

Eligible customers will receive a deposit refund for the return of current metal shower keys. Deposit refunds will be issued in accordance with Port District policy. Deposits held on file may not be applied or used to offset the cost of purchasing a new electronic key. Additionally, users wishing to obtain a new shower key will be required to sign a user agreement prior to issuance.
