# WINTERIZE YOUR BOAT

# Get your boat ready for winter!

Here are some helpful reminders to stay safe this winter:

- Visit your boat before the next storm. If you can't check your boat, find a responsible person who can.
- Check your dock lines. Tie lines securely to cleats; consider chafing gear and doubling-up lines.
- Replace your worn lines.
- · Bilge check.
- Be sure drains aren't blocked.
- Have an adequate number of appropriate-sized fenders.
- Store or tightly secure all sails, roller furlings, rigging, tarps, loose gear on deck.
- Close and secure hatches, ports and windows. Make sure they're water-tight.
- Make sure appliances like space heaters are not left unattended.
- Update emergency contact phone numbers and email address with the harbor office.

# **DREDGING OPERATIONS**

## ENTRANCE CHANNEL DREDGING

Dredging of the entrance channel is anticipated to begin during the week of November 13, 2017, and will continue through April 30, 2018.

During dredging operations, pass *Twin Lakes* on the east side (Crow's Nest side) of the channel unless otherwise



## NORTH HARBOR DREDGING

The 8" hydraulic dredge, *Squirt*, will be mobilized in the north harbor to address remaining shoaled areas authorized for dredging. Please read all gate notices and beware of submerged pipe and equipment hazards when operating in the area.

# **CALIFORNIA BOATER CARD INFORMATION**

## How to get your California Boater Card:

- Take and pass an approved boating safety course
- Apply for the California Boater Card
- Carry your card while boating

## Age Phase-In Schedule:

Boaters will be required to posses a California Boater Card, and the phase-in schedule is based on operator age.

- January 1, 2018 20 years of age or younger
- January 1, 2019 25 years of age or younger
- January 1, 2020 35 years of age or younger
- January 1, 2021 40 years of age or younger
- January 1, 2022 45 years of age or younger
- January 1, 2023 50 years of age or younger
- January 1, 2024 60 years of age or younger
- January 1, 2025 All persons regardless of age
