Chair Reed moved discussion of Item 9 (Reconsideration of a Formal Name for 2222 East Cliff Drive) ahead of the Consent Agenda. Chair Reed acknowledged the large crowd in attendance (estimated at 50) to discuss the naming of the Port District-owned building at 2222 East Cliff Drive.

Audience member Bengie Hodges introduced herself and expressed her interest in serving on the Board of Port Commissioners. (The appointment to fill the vacancy will occur at next month's regular public meeting.)

8. Approval of Minutes
  - a) Regular Public Meeting of August 27, 2024

MOTION: Motion made by Commissioner Goddard, seconded by Commissioner Geisreiter to approve consent agenda item 8.

## REGULAR AGENDA

9. Reconsideration of a Formal Name for 2222 East Cliff Drive (*Discussed out of order*)

Discussion: Commissioner Geisreiter stated that in accordance with the Port Commission Policies and Procedures Manual, as well as the Brown Act, he requested this item be placed on tonight's agenda. He stated that following the regular public session of August 27, 2024, where he voted in support of establishing a formal name for the Port District-owned building at 2222 East Cliff Drive as the Santa Cruz Waterfront Center, he recognized the error in his vote and would like to request that the Commission reconsider the prior decision.

Commissioner Geisreiter stated that if there is consensus among the Commission to rescind the prior decision / action from the August 27, 2024, meeting, that staff should then be directed to develop a formal naming policy for review at a future meeting to guide the Commission in establishing formal names for Port District-owned buildings.

There was consensus among the Commission to rescind the previously established name for the Port District-owned building at 2222 East Cliff Drive and discuss a path forward during tonight's meeting.

Vice-chair Smith stated that at the August 27, 2024, meeting he requested that establishing a formal name for the building be postponed to a future meeting to allow additional time for public notification and comment. He stated that it is his opinion that any name established for the building should reflect the rich history associated with Jack O'Neill and the harbor. He stated that he is supportive of establishing a formal name for the building during tonight's meeting that incorporates the O'Neill name. Commissioner Gertler agreed.

Members of the audience spoke in support of establishing a formal name for the building during tonight's meeting that incorporates the O'Neill name. Many suggested that the building be named the "O'Neill Building" or the "O'Neill Waterfront Center."

Commissioner Geisreiter stated that he is supportive of formalizing a naming policy prior to establishing a name for the building. He stated that having a formal naming policy will help establish general principles, naming conventions, and specific terms associated with assigning names to Port District owned buildings.

Vice-chair Smith again stated that he is supportive of the Commission establishing a formal name for the building during tonight's meeting that incorporates the O'Neill name. He stated that if a formal name will not be established during tonight's meeting, that at a minimum, the Commission should commit to incorporating the O'Neill name as part of any future assignment.

Commissioner Goddard provided context for the initial proposal to establish "Santa Cruz Waterfront Center" as the formal name for the building. He stated that it is his opinion that the name reflects the building's significant waterfront location and aligns with central activities that occur in the vicinity. He acknowledged the strong public interest regarding this item, but maintained his initial opinion and support for the Santa Cruz Waterfront name.

MOTION: Motion made by Commissioner Geisreiter, seconded by Vice-chair Smith, to rescind the Port Commission's previous action during the August 27, 2024, regular public session to formally name the Port District-owned building at 2222 East Cliff Drive as the Santa Cruz Waterfront Center; direct staff to develop a formal policy for naming Port District owned buildings; and incorporate the O'Neill name as part of any future naming assignment.

10. Acceptance of Final FY24 Audited Financial Statement

Discussion: Port Director MacLaurie thanked Paul Kaymark of Nigro & Nigro, as well as Finance Officer Eldridge, for their work on the FY24 audited financial statement. She stated that staff recommends acceptance of the final FY24 audited financial statement, which incorporates the following minor language change:

- Language added to address the reduction in marine general liability coverage limits in FY24 due to increasingly high insurance premium renewal rates (Note 14, page 40).

MOTION: Motion made by Commissioner Geisreiter, seconded by Vice-chair Smith to accept the FY24 audited financial statement.  
 - *Motion carried unanimously.*

11. Award of Contract for Santa Cruz Waterfront Center Painting Project

Discussion: Port Director MacLaurie stated that three bids were received for the project, with Selway Construction submitting the lowest bid in the amount of \$59,000.

She provided the figures below that represent the estimated construction budget based on Selway Construction's bid:

Contract Amount	\$59,000
<u>Contingencies (approx. 5%)</u>	<u>\$5,900</u>
Total Construction Cost	\$64,900

She stated that staff will perform outreach to tenants to inform them of the upcoming project and work to mitigate any project impacts. Additionally, she stated that after consulting with the painting contractor, the building color will remain a monochromatic white.

MOTION: Motion made by Commissioner Goddard, seconded by Commissioner Gertler to award a contract to Selway Construction; authorize the Port Director to execute contract; authorize a not-to-exceed amount of \$64,900; and approve an appropriation in the FY25 budget for the amount of the contract plus contingency.  
 - *Motion carried unanimously.*

12. Approval of Cash/Payroll Disbursements (*There was no discussion on this agenda item*)

MOTION: Motion made by Commissioner Geisreiter, seconded by Vice-chair Smith to approve cash and payroll disbursements for August 2024, in the amount of \$644,061.02.

- *Motion carried unanimously.*

13. Port Director's Report

Discussion: In response to a question posed by Commissioner Geisreiter, Port Director MacLaurie stated that there has been no additional communication from Verizon Wireless regarding negotiations for the installation of a cell tower in the vicinity of the O-Dock restroom.

Commissioner Goddard expressed appreciation for staff's participation in the County of Santa Cruz's Local Hazard Mitigation Plan updates.

In response to a question posed by Commissioner Geisreiter, Port Director MacLaurie stated that the City of Santa Cruz anticipates providing a notice of intent to award a contract to Shimmick Construction Company for the Murray Street Bridge Seismic Retrofit and Barrier Replacement Project in the coming days.

14. Harbormaster's Report

Discussion: Commissioner Geisreiter expressed appreciation for the new fisheries report layout and found the seasonal comparisons enlightening.

Commissioner Goddard recommended that the fisheries data be forwarded to Martin Associates to be utilized for the Port District's upcoming Economic Impact Assessment.

15. Facilities Maintenance & Engineering Manager's Report

Facilities Maintenance & Engineering Manager (FME) Wulf stated that the contractor is making progress on the North Harbor Transformer Project, aiming to finish underground work before the start of the rainy season. He stated that delivery of the transformers is expected by the end of the year.

In response to a question posed by Vice-chair Smith, FME Manager Wulf stated that staff has not been able to locate the source of excess water near the O-Dock restroom facility. He stated that despite extensive demolition and exploration, no viable leads were found.

SUBJECT: Appointment to Port Commission as Provided for in California Elections Code Section 10515 and Harbors and Navigation Code Section 6240.5

In accordance with the County Elections Department's administrative calendar, August 9, 2024, was the final day for prospective candidates to file a declaration of candidacy for the upcoming general election in November 2024. Declarations of candidacy were successfully filed for the Santa Cruz Port Commission's Division 1 and Division 3 seats, but not the Division 2 seat.

As a result, the Port Commission, in accordance with California Elections Code Section 10515(b) and Harbors and Navigation Code Section 6240.5, shall appoint a person to office to fill the Division 2 vacancy. The person appointed shall qualify and take office and serve as if elected at a general district election with a term expiring in December 2028.

The following eight candidates have submitted their names for consideration for appointment to fill the Division 2 seat:

- Ed Alaimo
- Robert DeWitt
- Bengie Hodges
- Tacettin Isik
- Charles Maier
- Lora Lee Martin
- Steve Richie
- Camille Sobalvarro

The following procedure is consistent with governing statutes and the process utilized by the Commission for previous appointments in 2003, 2009, 2012, and 2019.

Each candidate has submitted an application, a resume, and a statement of qualifications. Each candidate may be given an opportunity to make a statement, if desired, not to exceed three minutes. At the conclusion of the candidates' statements, the Commission will vote in public session.

| <b>Step 3: No Majority, Deliberation</b> | If no one candidate receives a majority on the initial vote, then the Commission may deliberate on candidates voted for in Step 1 and then call for another vote. |
| <b>Step 4: Second Vote Tally</b>         | A candidate must receive a majority (3 votes) to be appointed. If a majority is reached, appointment is made.   |
| <b>Step 5: No Majority</b>               | Start over at Step 1. All candidates are again eligible for consideration.  |

During this process, Commissioners may ask candidates for clarification or additional information as needed.

I am pleased to submit my application to serve on the Santa Cruz Port Commission. I have lived in Santa Cruz and the Monterey Bay region for over 36 years. I bring an understanding of the issues across our region and a deep commitment to shaping policies that positively impact our community, especially at the nexus of environmental issues and economic development. My experience includes land acquisition and development at the former Fort Ord, working with our regional marine science expertise, and complex project management at all levels of government. I offer a blend of skills that will complement the current commissioners and will support the Commission's mission of promoting public access, environmental stewardship, and economic viability and vitality for the port district.

Throughout my career, I have been at the forefront of regional initiatives. At the former Fort Ord, as lead negotiator I helped acquire over 2,400 acres of land for UCSC to establish a research park and for the CSU Monterey Bay campus. 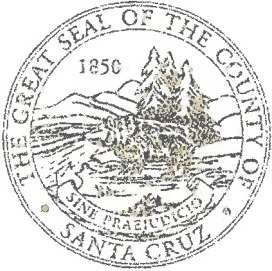

# SECTION I: OVERVIEW

The Santa Cruz Port District's 5-year Capital Improvement Program (CIP) provides a plan for the development, maintenance, improvement, and acquisition of infrastructure assets to benefit Santa Cruz Harbor's users, businesses, and visitors. It is intended to serve as a guiding document for planning, scheduling, and implementing capital improvements and planning projects over a five-year period.

Typical major CIP projects include ongoing infrastructure or facility maintenance needs, like dock upgrades, pavement repairs, and building restoration.

The CIP may also include services that indirectly lead to the construction of capital improvements, such as feasibility studies and investigative reports.

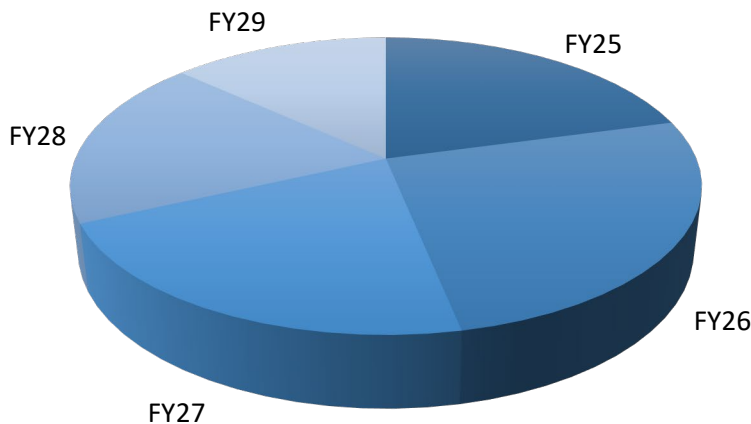
The current CIP was approved by the Port Commission as part of the District's FY25 budget process. A total of \$1,095,000 was allocated across 14 previously identified projects. This report summarizes the activities and milestones involved with the delivery of the Port District's CIP during the first half of Fiscal Year 25 (April 1, 2024, through September 30, 2024).

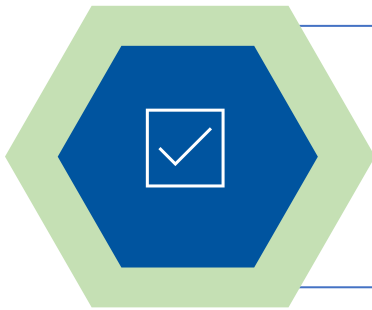
As of April 1, 2024, the Port District's Capital Improvement Program included 28 funded projects (including the Unallocated CIP Fund) and totaled \$7,393,214. 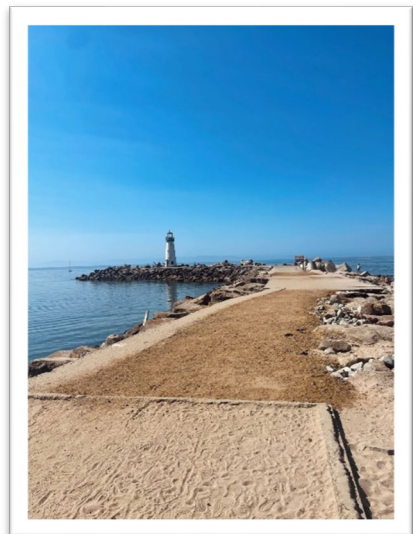
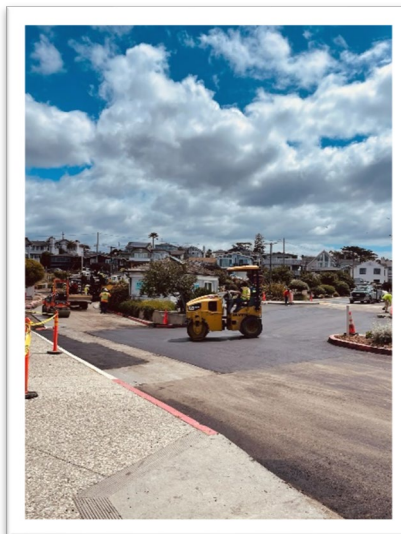
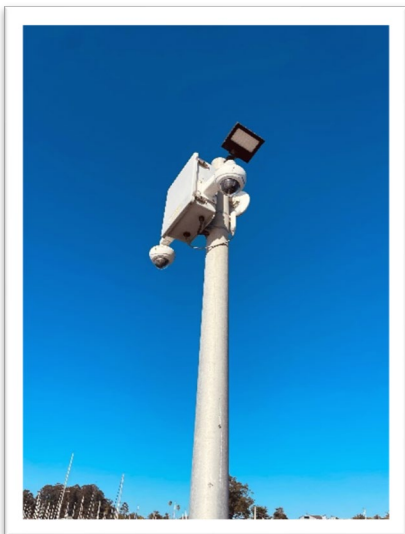
FIGURE 1: Completed Projects

This project was approved to provide for increased security systems throughout the harbor to reduce unauthorized uses and improve monitoring and enforcement capabilities. <b>FY25 funding contribution totaled \$12,000 for the acquisition of additional security cameras.</b>

Additionally, approximately \$80,000 in funding was allocated to repair the sinkhole that developed in the FF-Dock parking area. Work on that project is complete.

This project was approved to repair the southern portion of the jetty walking path, which was damaged during various storm events in 2023. 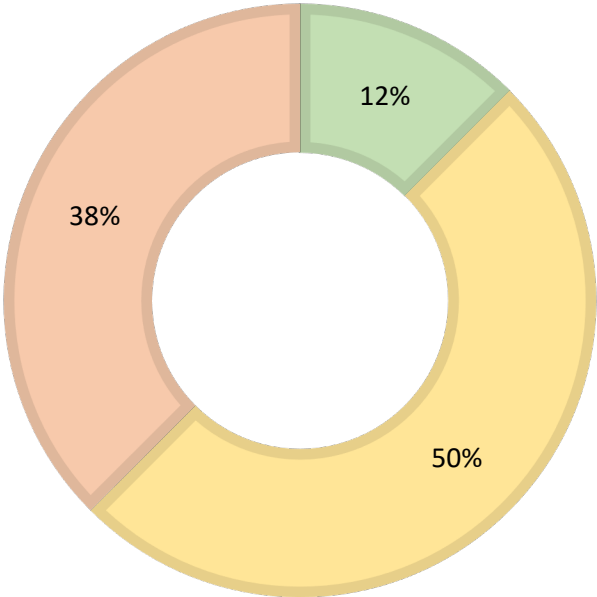

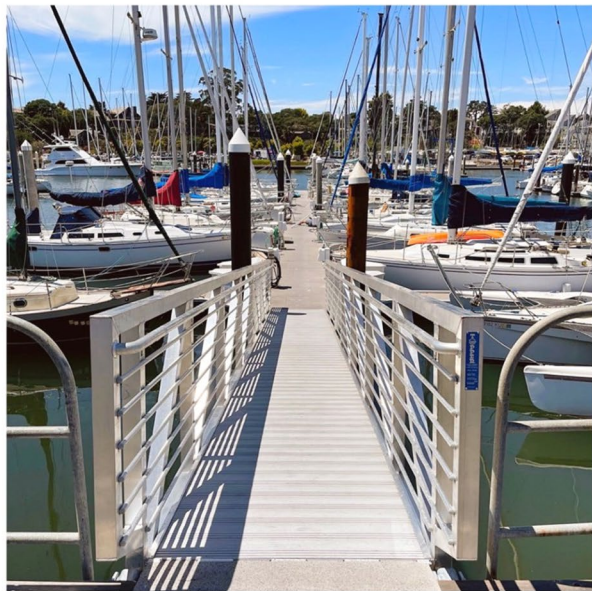


## SECTION 3: CONCLUSION

FY25 Appropriations Update – Dredge Reimbursement

October 1, 2024, marked the start of a new federal fiscal year. However, rather than enacting a final FY25 spending bill, Congress passed a continuing resolution to keep the government open and funded until December 20, 2024. As a result, the President's FY25 budget request that was carried forward in the House and Senate FY25 appropriations bills for Santa Cruz Harbor dredging operations remains pending until all congressional members return to Washington DC on November 12, 2024. At that time, the results of the 2024 election should be known and Congress can proceed with plans to complete all 12 of the FY25 appropriations bills by the new December 20<sup>th</sup> deadline.

Memorandum of Agreement Update – U.S. Army Corps of Engineers (USACE)

Staff continues to work with the USACE to renew the current Memorandum of Agreement (MOA) for operation and maintenance of the federal entrance channel. As part of the renewal process an updated economic analysis was required to substantiate federal interest in the project and determine the cost share calculation based off commercial activities at Santa Cruz Harbor. A review of the economic analysis has been completed by the South Pacific Division (SPD) and sent back to the San Francisco District for further vetting. Staff has been working with the San Francisco District and SPD to reach agreement on the methodology for estimating commercial and recreational use at the harbor (previous methodology used in the 2011 economic analysis was deemed to be inaccurate by SPD). Staff has been meeting with the Corps 2-3 times each week to resolve these issues and ensure the document is completed and transmitted to Headquarters for final approval in the coming months.

Water Board Dredge Fee

The State Water Resources Control Board recently increased annual dredge discharge permit fees from \$0.653/CY to \$0.921/CY, with a minimum annual fee of \$4,212. The Water Board assesses the Port District an annual dredge discharge permit fee on sediment dredged from the north harbor only, which averages approximately 3,900 CY/year.

Administrative Cost Savings

Over the last year, staff has worked to reduce costs for various administrative services, like recurring IT support, phone systems, and armored courier services. An overview of the services and associated cost savings is below:

City of Santa Cruz - Coastal Coordination Group Meeting

Staff participated in a coastal coordination group meeting at Netcom on October 1, 2024. The group, organized by the Santa Cruz City Office of Emergency Services Manager, was created to enhance public safety coordination along the city coastline. The group includes representatives from the Santa Cruz Fire Department, City of Santa Cruz Lifeguards, Santa Cruz Police Department, Santa Cruz Municipal Wharf, California State Parks, and the Santa Cruz Seaside Company.

SAVE Grant - Vessel Disposal

Staff facilitated a vessel disposal day on September 27, 2024, which ensured that grant funds were fully expended by the September 30, 2024, deadline. Over the last twelve months, thirty vessels have been disposed of using the Department of Boating and Waterways Surrendered and Abandoned Vessel Exchange (SAVE) Grant Funding.



County of Santa Cruz - Readiness Working Group Meeting

Staff participated in a workshop meeting hosted by the Santa Cruz County Office of Response, Recovery, and Resilience (OR3) at the Watsonville Police Department on October 2, 2024. The Readiness Working Group (RWG) was created to support County OR3 in the development of a comprehensive evacuation plan as part of an annex to the newly approved Santa Cruz County Emergency Operations Plan. The RWG is made up of representatives from fire, law, emergency medical services, various county departments, healthcare, transportation, education, community groups, and other stakeholders.

### Boatyard - Winter Preparation

Boatyard staff have been busy preparing for the rainy season in accordance with the District's Stormwater Prevention Pollution Plan (SWPPP). The yard has been pressure washed twice in the last month and on Friday, October 11, 2024, the vault and pretreat tank were pumped. New in-ground filters have been installed throughout each catch basin and the trench drain.

### Fishery Update

Rockfish regulations changed on October 1, 2024, and anglers are only permitted to fish in 50 fathoms or greater through October 31, 2024. On November 1, 2024, the regulations will reverse, and fishing will be permitted inside 50 fathoms through November 30, 2024. Starting December 1, 2024, through December 31, 2024, it will again switch back to an offshore-only fishery (50 fathoms or greater). The CA Department of Fish and Wildlife imposed these depth restrictions to protect the Quillback rockfish stocks.

A small handful of Bluefin Tuna have been quietly landed out of Santa Cruz over the last month, but offshore wind conditions the last few weeks have prevented much exploration. Hopefully, the wind will lie down over the next month, and we see some landings.

Unfortunately, there is no known progress on the highly anticipated salmon closure disaster relief checks.

**Fisheries Report**

The fisheries report consists of data from two sources: the Department of Fish and Wildlife (DFW) and H&H Fresh Fish (resident fish buyer). The data from DFW is partially redacted in accordance with federal fisheries laws. Data is considered confidential when less than three separate vessels land species at any one port. For species landed by three or more separate vessels, the full data is made public and includes weight and value. For other data, the species landed is shown with no weight data.

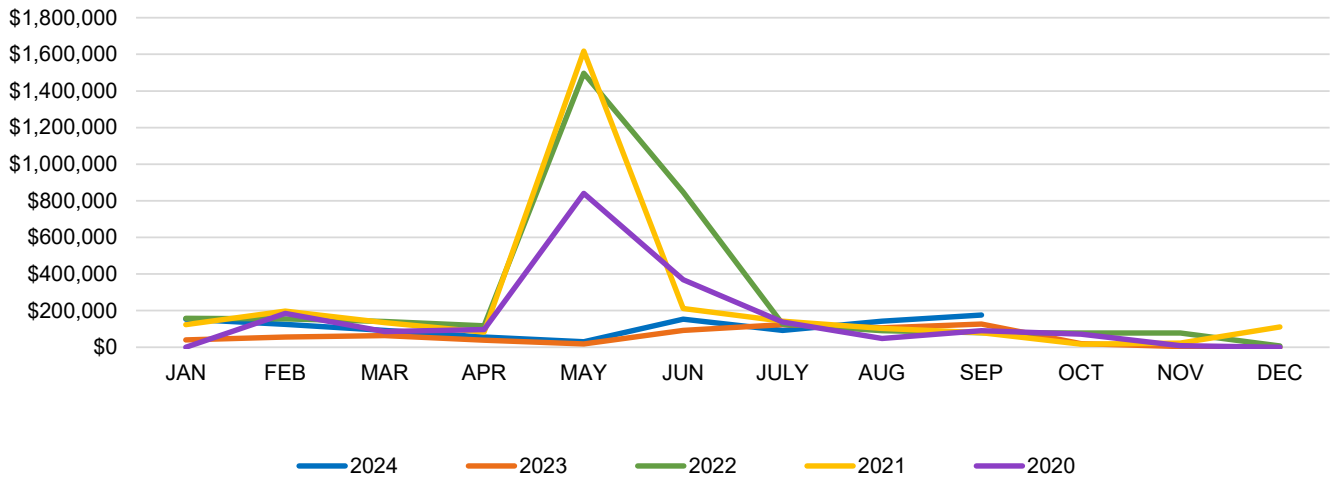

### **Dredging Operations:**

#### Twin Lakes

The dredge crew is finishing up maintenance on *Twin Lakes* for the upcoming dredge season. The Christmas tree, snorkel, and walkways were installed on October 9, 2024. Due to upcoming low tide conditions, the crew plans to move *Twin Lakes* from its off-season mooring in the north harbor to the entrance channel during the low tide on November 14, 2024.

#### Squirt

*Squirt* will not be utilized during the 2024-25 dredge season and will remain hauled out in the boatyard for extended maintenance.

#### Dauntless

The crew has been working hard to complete maintenance on *Dauntless*, including painting the hull, rebuilding the cabin, replacing and painting sections of rusted metal, and installing a new low-voltage electrical panel. They continue to work on a welding and fabrication repair to the A-frame that will be completed on October 18, 2024.

### **Maintenance:**

#### North Harbor Transformer Replacement Project

The Port District's contractor, Anderson Pacific, continues with the underground conduit installation on the east side and has nearly completed as far as J-Dock. A short section of conduit will be installed in the RV parking area in mid-November when the spaces are scheduled to be clear of park guests. In the meantime, Anderson Pacific has moved on to completing the last section on I-Dock.



D-Dock Restroom Facilities Reroofing Project

Staff has executed a contract with Pio's Roofing for the D-Dock restroom facility roof replacement in an amount not to exceed \$14,350. Pio's Roofing is currently completing another job and will begin the roofing project at D-Dock in the coming weeks.

FF-Dock Row Rack Jet Float

On October 4, 2024, maintenance staff performed necessary repairs and replaced damaged sections of jet floats at the FF-Dock rowing facility. This critical repair restored the functionality and safety of the jet float system.

Metal Canopy Structure Project

SSB began staging in the area on Thursday, October 10, 2024. Construction commenced on October 14, 2024, and is anticipated to last approximately six weeks.

### **FEDERAL ENTRANCE CHANNEL DREDGING**

Federal entrance channel dredging commenced on November 21, 2023. The crew began the season with adequate depth from a mild summer (see Attachment A – Pre-Dredge Season Survey), but extreme winter weather in December began a period of increased shoaling at the entrance. The atmospheric river events, stormy conditions, and heavy seas that persisted from December through March posed significant challenges to the operation. Sand was almost continually deposited during the period between December and May (see Attachment B – Mid-Storm Survey).

During the weeks that followed, the dredge crew worked an extended schedule to address the significant shoaling. By the second week of April, enough material was dredged, and the entrance was passable for most vessels at high tide (see Attachment C – Mid-Dredge Season Survey).

*Twin Lakes* experienced numerous and significant breakdowns this season, including three Christmas tree failures, hydraulic line and hose failures, main circuit breaker failure, various C18 engine electrical issues, and wire cable breakage resulting in the loss of one anchor. Dredge staff kept up the effort despite the failures and were able to provide a good entrance channel design depth for the boating community during the summer season. In total, approximately 21 working days were lost to equipment failures.

As a result, the Port District was granted a three-week extension to the 2023-24 dredge season to allow the crew to address shallow areas along the shoulders of the entrance. Dredging concluded for the season on May 23, 2024, with favorable depths (see Attachment D – Post-Dredge Season Survey).

### **NORTH HARBOR DREDGING**

Dredging in the north harbor commenced on November 6, 2023. The crew made significant progress, despite winter storms, and successfully achieved designed depths in the J/J and X/J fairways (and slips). Dredging in the north harbor concluded on February 29, 2024.

As a result of last season's progress deepening the north harbor slips and fairways, north harbor dredging is not planned for the 2024-25 season.

### **BEACH INFRASTRUCTURE**

During the dredging season, the east discharge pipe developed a leak at the valve box on Harbor Beach. The dredge crew removed the damaged pipe section and fabricated and installed a new steel pipe section. An internal pipeline inspection by the City of Santa Cruz's Storm Water Management Program's mobile camera revealed the remaining pipe to be in good condition.

## MAINTENANCE PLAN

As the dredging season ends, the annual maintenance program begins. All pipeline was demobilized from the beach by May 30, 2024, and *Twin Lakes* was moved back to its mooring on June 11, 2024.

The following maintenance items are being addressed during the offseason:

### Squirt

*Squirt* will not be utilized during the 2024-25 dredge season, so maintenance work has been postponed until later in the year. Staff has been completing some painting as time permits.

### Dauntless

*Dauntless* was hauled out at the boatyard on July 17, 2024. In addition to the routine off-season maintenance of the hull and other equipment, the crew rebuilt portions of the cabin where severe rust was present. All interior wood panels were replaced, and a new low-voltage electrical panel was installed. The exterior of the cabin was cleaned and painted.

### Twin Lakes

Routine yearly maintenance has been performed on *Twin Lakes*. Peterson CAT ran a load test on the C18 engine. Hydraulic lines have been replaced with stainless steel tubing and hydraulic hoses on the ladder and snorkel have been replaced. The C18 muffler has been replaced with a hospital-grade low decibel unit, and painting remains ongoing.

### Christmas Tree

After removing the Christmas tree from the dredge, several large cracks in various sections of the tree were identified. To repair the cracks, the flanges were rewelded and gussets were added to provide additional strength going forward. The crew also replaced all bushings on the tree sheaves. More extensive Christmas tree repairs are planned as part of the future haulout of the dredge.

### Standby Generator

The standby generator, which is used to run all external safety lighting, as well as the cathodic protection equipment when the dredge is not operating, performed well this last season. No significant repairs are planned during the offseason, but the generator will receive a standard preventative maintenance service.

### Hydraulic

All hydraulic lines in the pump room have been replaced with stainless steel tubing to give the system more durability.

### Snorkel

The snorkel elbow has been removed and inspected. There were signs of wear, which have subsequently been rewelded with hard facing. To ensure continued operability of the snorkel, the high-pressure jet pump piping that became bent during the season has been straightened out and reattached. The elbow and the chopper's head were hard-faced where there were signs of wear.

### Booster Pump

The booster pump performed well this last season with no issues.

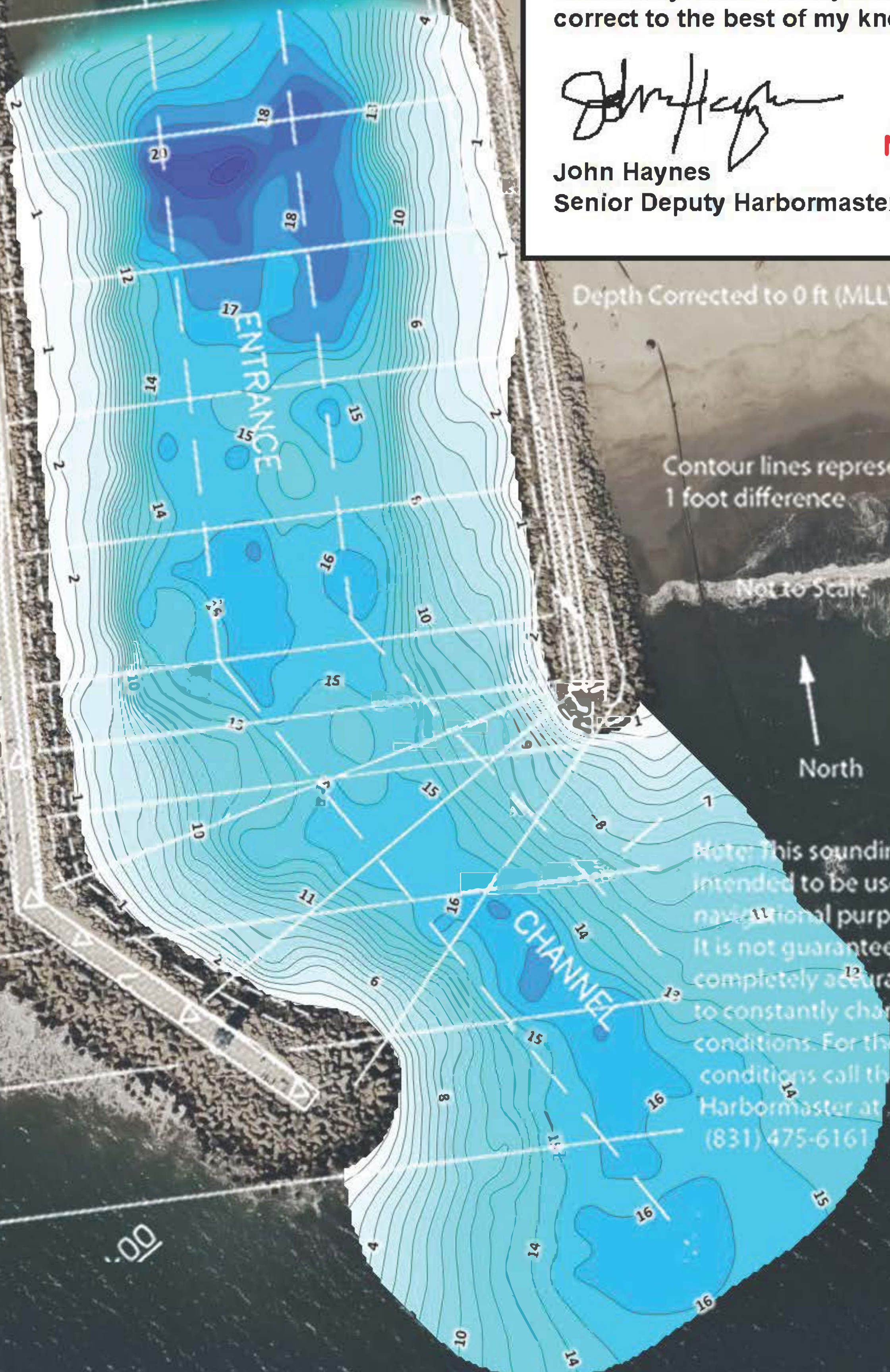

**Fuel Dock Revenue**



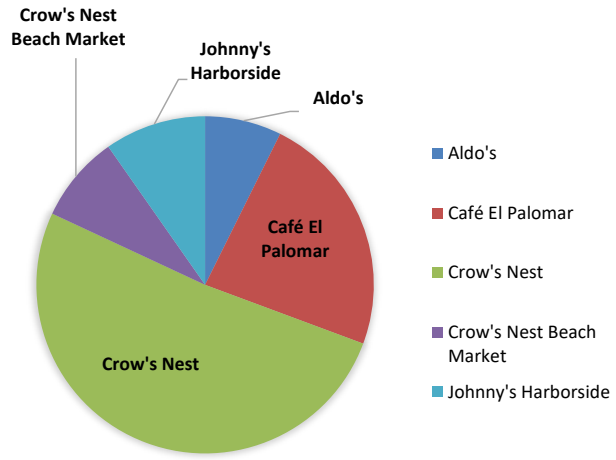

***Search and Rescue, Patrol Boat Response***
