Each year, the Santa Cruz County Assessor's office charges possessory interest tax to vessels berthed in and to rental properties within the Santa Cruz Harbor. The possessory interests are assessments made for the private use of otherwise nontaxable publicly owned property, including boat slips.

DREDGING UPDATE

The dredge crew began work in the entrance channel on November 8, 2016 with the new dredge, *Twin Lakes*. Harbor staff underwent extensive training, including the cross-training of all employees in dredge operations. The dredge crew extended their work schedule in November and December to ensure that the entrance channel remained open.

Prior to transiting the entrance, mariners are advised to check tide and weather conditions and review the most recent entrance survey <u>online</u>. Be sure to know what your vessel draws to ensure safe passage.
