Dear Santa Cruz Port Commission

Jack O'Neill's history within the harbor has helped make it what it is today. The harbor has received a tremendous benefit from the O'Neill boating businesses over the years, including his sailing instruction. Jack helped to finance the restoration of the Jack O'Neill building, and founded, led and was a top funder of the O'Neill Sea Odyssey Program. All of these entities have served the harbor and Santa Cruz Community by increasing tourism and generating revenue for the Port District and related businesses.

Most importantly, Jack's legacy began with his efforts to keep people warm while surfing in colder waters by innovating the wetsuit, which over 70 years has revolutionized ocean access, a value the Santa Cruz Harbor shares. O'Neill Sea Odyssey has served 127,000 students from the Monterey Bay and Santa Clara County region area by bringing them to the harbor and providing them with a life changing educational experience on the ocean.

All other elected officials in Santa Cruz County and the Cities within it, and the Chamber of Commerce, have all helped to preserve Jack's legacy in Santa Cruz through giving proclamations, acknowledgements, named places and a street. 1989 Pepsi-O'Neill Cold Water Classic, O'Neill received Recognition of extraordinary contributions to the growth of surfing locally, nationally, and internationally. In 2010, O'Neill received the City of Capitola Mayor's Proclamation Business of the Year by Mayor Sam Storey and California State Senator Joseph Simitian, as well as received A certificate of Congressional Recognition of outstanding and invaluable service to the community by Congressman Sam Farr, and California Legislature Assemblymember William Monning commending charitable programming and outstanding volunteer, deserving of commendation and recognition as a continuous supporter and donator to many local community events and who sponsors important local economy boosting contests. In 2012, the parking lot area by the Dream Inn was designated by the state as a California Point of Historical Interest where Jack had his surf shop. In 2013, Santa Cruz Chamber of Commerce gave Jack Man of the Year Lifetime Achievement Award. In 2014, the Jack O'Neill Lounge displaying the O'Neill history opened. In 2014, the 55-foot-long mural featuring archival photographs of milestones in O'Neill's personal history located adjacent to the parking lot below the Dream Inn. In 2016, the Jack O'Neill Way Street dedication by the City of Santa Cruz, by Santa Cruz City Councilman David Teresas. In 2017, In honor of Jack O'Neill's many contributions to surfing, the local community, and the well-being of the oceans, the city of Santa Cruz declared July 9th to be Jack O'Neill Day and redubbed the lot next to his home Jack O'Neill Park. November 30 2022, O'Neill Surf Shop on 41st Ave was recognized as a significant historical landmark by Santa Cruz Museum of Art and History's Historical Landmark Program making the Surf Shop a new State of California Point of Historical Interest. The City of Santa Cruz Mayor's Proclamation making Jan 9 2024 O'Neill Cold Water Classic Day in the city of Santa Cruz by Mayor Fred Keeley.

It is therefore disheartening and quite perplexing that 3 of our elected port commissioners, Toby Goddard, Steve Reed, and Reed Geisreiter, are doing the opposite of what all other elected officials have done in Santa Cruz County and the State of California by voting to remove Jack O'Neill's name from the building he built in the harbor. That very building would not be here today without Jack's investment and hard work. As voting constituents within the Santa Cruz Port Commission District, we are letting you know that your vote and decision to remove Jack O'Neill's name from the building does not represent what the community wants. Had the Port Commission sought public input and the input from their constituents they would have been able to make a more informed decision about the negative impact and opposition the vote to remove Jack's name from the building has caused. Mistakes can always be

rectified, and we are asking the Commission to include the public and constituents they represent and rescind the decision to remove Jack O'Neill's name from the building. A better more suited official name that acknowledges and preserves the building history and Jack's contribution to the harbor would be O'Neill Waterway Center.

The O'Neill Building, A Short History

"Harry Hind and I (were) old-time surfers from Kelly's Cove and Ocean Beach, San Francisco. We surfed there in the 1950s, and became good friends. I had the idea to open a surf shop at the Santa Cruz harbor, and I asked Harry if he could back me on the deal. He said he would."

"Then Harry brought in a CPA and an attorney, and soon our surf shack became an 8,500-square-foot building."

We got approval from the harbor and built it in 1965. In 2000, Harry and I donated this building to the Sea Odyssey..."





Over the years the building housed O'Neill Yachts, O'Neill Dive Shop, O'Neill Surf Shop and O'Neill Sea Odyssey.

Jack was one of many with great harbor stories. After the 1964 tsunami washed the dredge to sea, Jack and two friends located and returned it to the harbor.



It was renovated in 2004-2005. O'Neill Sea Odyssey paid \$1.56 million, or 47% of the cost, mostly grants and donor funds, plus a loan.

Brian Foss said OSO's financial involvement made renovation possible.

The California Coastal Commission granted a waiver of their review of renovation due to the presence of OSO's education center and the Surfrider water quality lab – priority ocean dependent uses under the Coastal Act.





O'Neill involvement is part of the harbor's rich history, and speaking for myself, I hope it won't be lost.




